BCS Enrollment Policy:

As approved on December 9, 2015, enrollment to Bloomsburg Christian School will be limited to those families with:

1. At least one parent and/or guardian who professes salvation through personal faith in Jesus Christ and a life of seeking His righteousness, or who demonstrates significant interest and openness to this if there is uncertainty.
2. Both parents and/or guardians (with custody) must:
 - a. Support a Biblical and Christ-centered education, including teaching the necessity of salvation through personal faith in Jesus Christ and a life of seeking His righteousness.
 - b. Agree to respect and follow the policies and leadership of Bloomsburg Christian School which are established and directed under the authority of Calvary Baptist Church.
 - c. Personally uphold the Biblical standard of marriage and sexuality of one man and one woman living in faithfulness to one another and refraining from sex outside of marriage.
3. The student has not demonstrated patterns of unacceptable attitudes, behavior, or work.
4. The student is willing to attend BCS.
5. The student evidences sufficient academic skill on an entrance examination.
6. No student will be enrolled if he or she is married, or will continue to be enrolled if he or she marries during the school year.

ACCIDENT RELEASE: On field trips and excursions, students will need to be transported in private cars of parents, teachers, or in a school vehicle. Reasonable precaution will be taken to provide for the safety of the children.
